



海洋公園 (本園) 熊貓早餐會參加細則

甲部: 參加細則

1. 11 歲或以下之參加者需由家長/監護人*陪同。
2. 3 歲或以下小童只提供座位。
3. 活動主要以廣東話，輔以英語進行。
4. 請於活動當日上午九時正至九時十五正，前往海洋公園正門售票處領取門票，工作人員將以參加者之姓名、參考編號及訂購活動時所有的信用卡以作核對之用。
5. 正門入口處設有車位，數量有限，先到先得。私家車星期一至星期五收費為每日 HK\$70，星期六、日及公眾假期收費為每日 HK\$80。
6. 每節名額: 40
7. 坐位將以先到先得形式分配。因場地設計所限，參加者可能被安排於不同餐桌用膳。

* 備註:「監護人」的涵義與《未成年監護人條例》中該詞的涵義相同。

乙部: 參加者須知

1. 由於亞洲動物天地室溫較低 (15-18°C)，我們建議參加者帶備外衣來參與這活動。
2. 請在任何時間都遵從工作人員指示。

丙部: 報名方法

1. 申請表格及有關詳情，可於以下途徑索取：

 - ◆ 本園遊客服務處; 或
 - ◆ 親身前往本園正門票務處
2. 參加者可以下列方式報名：
 - ◆ 透過網上及傳真: 最少活動日前 1 天下午 3 時前;
 - ◆ 親臨海洋公園正門票務處: 最少活動日前 1 天下午 3 時前;
2. 申請之活動日期必需為三個月內 (由申請日起計算)。
3. 本園將於收到網上或傳真申請表後以電郵通知參加者:
 - 3.1 參加費用將於收到網上或傳真申請表後以信用卡繳交; 或
 - 3.2 於確定信發出日期起計算兩日內以現金轉帳至海洋公園公司之香港上海匯豐銀行戶口方法繳交。參加者必須把存款收據傳真至 2553-4483 海洋公園教育部收。參加者請於活動當日出示收據正本以供核對。(只限申請最少活動日前 5 天才適用)
 - 3.3 如參加者未能於以上所述時間內繳交參加費用，其申請將會當作自動棄權論。本園有權把該參加者之活動日期撥予其他申請者。
4. 所有已繳交之參加費用恕不退還而活動名額亦不能轉讓他人。
5. 除丙部所列明之情況外，已確定之活動日期恕不更改。
6. 參加者必須準時於指定地點集合，逾時不候。本園亦有權決定是否讓逾時者參加此活動。

丁部: 特殊情況而取消

本活動有可能因以下之特殊情況而取消：

1. 惡劣天氣包括但不限於 8 號或以上之颱風訊號或黑色暴雨警告，以至本活動不能進行；或
2. 參加者、本園職員或動物的安全理由；或
3. 本園之動物及教育部總監或其授權人擁有最終決定權即時終止或取消本活動。

因上述情況而受影響之參加者，本園會重新安排活動日期及時間。



Ocean Park (The Park)

Breakfast and Pandas Rules and Regulations

Section I: Programme Details

1. Any child (age 11 or above) must be accompanied by a parent/guardian*.
2. Children under 3 will be provided with seats only.
3. The programme will mainly be conducted in Cantonese supplemented with English.
4. For ticket collection and gathering, please approach the Ticketing Counter at ocean Park Main Entrance from 9:00am to 9:15am on the programme day, with your name, reference number and the credit card used in the payment for verification.
5. Parking spaces are available at Main Entrance. The daily fees for private car are HK\$70 for weekdays and HK\$80 for Saturdays, Sundays and public Holidays.
6. Capacity per session: 40
7. Seats are arranged on a first-come-first-served basis. Due to the venue design, participant might not be sited at the same table.

* Remark : 'Guardian' has the same meaning as in the < Guardianship of Minors Ordinance >.

Section II: Regulations for participants

1. Due to the low temperature (15-18 °C) in the Amazing Asian Animals, we recommend participants to bring along a jacket with them.
2. Please follow the instruction of our staff at all times.

Section III: Enrolment

1. Application forms and information can be obtained from the following locations:
 - ◆ Ocean Park website: www.oceanpark.com.hk ;
 - ◆ Guest Relations Offices at the Park's Entrance ; or
 - ◆ Ticketing Offices at the Park's Main Entrance
2. Reservations can also be made by the following methods:
 - ◆ Via Internet or Fax: A minimum of 1 day advance booking before 3pm.
 - ◆ In-person at Ocean Park Ticketing Office, Main Entrance: A minimum of 1 day advance booking before 3pm.
3. Payment must be settled by:
 - 3.1 Payment will be settled within 1 day by Credit card; or
 - 3.2 Payment must be settled within 2 days of confirmation by cash transfer directly to Ocean Park Corporation account at The Hong Kong and Shanghai Banking Corporation. Please send a copy of the receipt for the transfer to Education Department by fax at 2553 4483. Please present the original bank receipt on the date of Encounter. (This payment method is for the booking with a minimum of 5 days advance)
 - 3.3 If the payment is not received within the aforementioned period, the application will automatically be cancelled and the vacancy will be made available to other interested parties.
4. All payments made are non-refundable and non-transferable.
5. Programme date cannot be changed after confirmation, except in the circumstances stated in Section IV.
6. Please arrive the gathering point punctually. Late-comer might not be admitted to the programme.

Section IV Cancellation:

Cancellation of the Programme may be made in the following circumstances:

1. Inclement weather, including but not limited to the hoisting of typhoon signal no.8 or above or black rainstorm warning; or
2. The safety issue regarding any participant, staff or dolphin; or
3. Decision for immediate cancellation of the Programme shall be at the sole discretion the Director of Zoological Operations & Education Division of the Park or his/her delegate.

Programme will be re-scheduled for the affected participants and accompanying guests under the above mentioned circumstances.
